

That's All Folks! Clearview Exits QC Supply

Ten acquisitions and organic growth led to doubling of EBITDA



Stamford, CT, January 6, 2017 — After a three-and-a-half-year hold period during which the company completed ten acquisitions, Clearview Capital Fund II, LP (“Fund II”) today announced the sale of its majority interest in QC Supply, LLC (“QC”) to an undisclosed financial buyer. The transaction closed on December 29, 2016.

Based in Schuyler, NE, QC is a rapidly growing specialty distributor and solutions provider to the swine and poultry markets. The company operates 21 locations in ten states and serves most of the top growing regions in the United States.

“During our investment period in QC, we were able to achieve all of our strategic objectives which included helping the company’s founder and an equity partner in the investment, Lonnie Kitt, recruit a top-notch management team to succeed him as he

moved to the role of Chairman,” said James Andersen, Co-Founder and Managing Partner of Clearview Capital. “Along the way, we were also able to complete ten accretive acquisitions, expand from a regional to a national footprint, double EBITDA and build the infrastructure for continued profitable growth into the future.”

“Clearview Capital exceeded our expectations as an investment partner,” said Jason Luster, President and CEO of QC. “QC greatly benefitted from our alliance by achieving both acquisition-led and organic top and bottom line growth while professionalizing the business along the way, and our collective efforts have established a solid foundation for continued accelerated growth.”

“The sale of QC is the eighth exit from Fund II and the fourth exit from a Clearview fund in the past 18 months,” said Calvin A. Neider, Co-Founder and Managing Partner of Clearview Capital. “We remain aggressive buyers of new platforms in Fund III even as we harvest companies we have built successfully in Fund II.”

Clearview Capital's other holdings include Wilson Orchard and Vineyard Supply, LLC, a designer and supplier of agricultural irrigation systems and orchard & vineyard supplies; Controlled Products, LLC, a manufacturer and distributor of premium quality synthetic turf; Advanced Medical Personnel Services, Inc., a provider of nationwide healthcare staffing solutions; Xcellence, Inc. d.b.a. Xact Data Discovery, a provider of discovery and data management services; Northwest Cosmetic Laboratories, LLC, a formulator and manufacturer of cosmetic and skin care products for prestige brands; Novik, Inc., an innovator, manufacturer and distributor of polymer building products; St. Croix Hospice, LLC, a provider of high quality, palliative care for hospice patients; GCR, Inc., a professional services firm delivering technology solutions to governmental and commercial clients; Child Health Holdings, Inc. d.b.a. Pediatric Health Choice, the country's largest provider of prescribed pediatric extended care (“PPEC”) centers for medically complex children; and Pyramid Healthcare, Inc., a provider of substance abuse and mental health treatment programs for adults and adolescents.
