Dear Sir or Madam,

I'm sure my opinion doesn't matter to PNC regarding the closing of this branch, but I thought you should understand the difficulties this will cause me and many other members of this community. Along with the closing of our other Ocean City branch located on 32nd Street a few years ago.

Ocean City is a small beach town with a 3 lane highway traveling from one end of the town to the other; about 10 miles. This highway is crossed by approximately 145 numbered streets with traffic signals every three blocks. To drive the entire length of this highway or even half of it, is not a good experience, especially from April thru October. Many residents and summer visitors depend on our bus system to travel Coastal Highway, but it wouldn't be feasible for them to transfer at the bus depot to another bus that still wouldn't get them where they needed to go.

For me to drive to your West Ocean Branch from my home at 136th Street would be a one hour round trip. From my workplace at 59th Street it would take about 45 minutes depending on traffic. The banking public does not have this amount of spare time to handle their banking needs and no one can afford to take time off from work.

My branch suggested that I could use the PNC in Delaware on route 54, but that one probably will be more inconvenient because of the extremely heavy traffic on a two lane road. No one suggested the branch in Ocean Pines that is a mile closer and offers more services. Is that one closing next?

Another inconvenience is the lack of a later drive thru time. Closing at 5 PM is not acceptable for businesses needing to make deposits and residents who work. PNC has advertised their "Deposit Easy" ATM, but none are located in our area. We are left with no other choice than to choose a new bank.

Nothing will change, but now you will know how this inconsiderate change will affect so many customers.
