- Electronic Remittance Advices (ERA) are accessible in a variety of ways to meet your current needs:
 - You can download human-readable PDF files to view or print for manual payment application, just like opening mailed EOPs.
 - You can download EDI-formatted payment files to automate posting to your practice management system.

- Or, you can arrange for data transmission of Electronic Remittance Advice (ERA) files to fully automate the posting of your claim payments. (Fees may apply.)
- Robust search tools enable you to research up to seven years of archived payment and claims data quickly and easily.¹
- Online bank account management gives you control over where your EFT payments are deposited, regardless of where you bank.
- You can set up and manage access for multiple users in your office.

- 1 Grab an EOP from a participating payer and a voided check from your bank account.
- 2 Go to rad.pnc.com and click "Register for Portal and Online Payment Service" in the upper-left corner.
- 3 Follow the on-screen instructions and enter the requested information.
- 4 Your account information will be verified, and within a few days you can begin receiving electronic payments and remittances.
